Terms and Conditions of Carrefour européen asbl

1. The Carrefour européen asbl, hereinafter referred to as the 'Association', declines any liability for, and cannot be held responsible for, any consequences or harm of a material or bodily nature in the event of accidents suffered by a participant during or in connection with activities of the Association. Each participant is responsible for taking out individual insurance cover against risks involved in participation in those activities including personal insurance against third-party risks.
2. The Association cannot be held responsible in the event of theft, disappearance, damage or other loss of personal valuables, goods or equipment belonging to any participant in its activities.
3. The Association declines any liability for, and cannot be held responsible, in the event of cancellation of scheduled activities or of changes to, or affecting, those activities.
4. **Solely the general terms and conditions of the travel agency mentioned hereafter or in the description of the tour shall apply in the event of cancellation.**
5. Signature of this enrolment form implies acceptance of financial responsibility for the services thereby requested and of the obligation to make full payment for the participant's share of the costs involved.
6. The role of the Association is limited to collecting and centralising requests to participate in a given activity and to transmitting such requests to the travel agency which is solely responsible for making the travel arrangements. Under no circumstances can the Association be deemed to be the travel organizer or travel agent for the purposes of Directive (EU) 2015/2302 of the European Parliament and of the Council of 25 November 2015 on package travel and linked travel arrangements or of provisions of the Belgian Law dated 21 November 2017 on package travel, linked travel arrangements and travel services. The agency or operator entrusted with organization and implementation of the travel arrangements is exclusively liable for the proper organization of any tour, to the exclusion of any liability whatsoever on the part of the Association or its officers.

Terms and Conditions of Barton Hill & Armchair (The Company)

Cancellation Policy

- **All deposits paid are non-refundable.** However, in the event of a full group cancellation the Company will work with suppliers to ascertain if any payments made can be refunded or rolled to a future booking.
- No refund will be made for cancellations within 2 weeks of arrival date or for any services confirmed but not used during the programme/itinerary.
- The Company reserves the right to levy 100% cancellation fees for any cancellation occurring within 4 weeks of arrival date.

Brussels Airlines Cancellation Policy:

- Between date of booking and 12 weeks before departure: 20% of seats can be cancelled without charge. 30% cancellation fees for additional cancellation.
- Between 12 and 8 weeks before departure: 50% cancellation fees
- Between 8 and 6 weeks before departure: 75% cancellation fees
- Between 6 weeks and date of departure: 100% cancellation fees
